In this situation, the Arabic is considered as one of seven subjects (IGCSE) required in clause 1.</li> <li>Pass in Islamic Education (for Muslim students).</li> <li>For IGCSE subjects, no school certificates are admissible. It's obligatory to get certificates issued by British Examination Boards which shall be approved by the school.</li> </ol>
