Circular No. (10) of 2024

General controls for school uniforms for students and the uniforms and appearance of staff in private schools and kindergartens

The Department of private schools and kindergartens presents you with our best regards, and we thank you for your efforts in monitoring the progress of the educational process efficiently and effortlessly. With reference to the above topic, and to Circular No. (8) of 2019 regarding school uniforms (attached), and out of commitment to the values and customs of Qatari society, it was decided to oblige private schools to have general controls on school uniforms for students and staff in private schools and kindergartens.

According to the following:

First: Specifications of school uniforms for students

Adherence to the general regulations for school uniforms for students in private schools according to the following (illustrative pictures attached)

Specifications of school uniforms for students in private schools starting from the primary stage and above (boys - girls)

Second: General controls for school uniforms for students

- Commitment to a modest school uniform that is consistent with the values of Qatari society.
- Emphasis on students (females) that the quality of clothing fabrics is opaque and does not trace the outlines of the body in all types of uniforms (School uniform, sports uniform, swimming uniform).
- Adherence to previously issued Circular that not to mix between students in swimming classes starting from the fourth grade of primary school and above.
- The choice between wearing the Qatari uniform and the school uniform is subject to school policy.
- The requirements and controls specified in this circular generally apply to private schools that do not adopt school uniforms for students. In terms of length specifications for shirts, skirts, swimwear, and sportswear.

Third: Specifications of the uniform and general appearance of staff in private schools and kindergartens

Adherence to the general regulations for the uniform and general appearance of school staff in private schools and kindergartens according to the following: Specifications of school staff uniforms (males - females)

Examples of inappropriate clothing for staff (males and females)

- Worn clothes.
- Shorts. Above the knee.
- Sleeveless jackets.
- Tight or compression pants. T-shirts and shirts that expose the neck, shoulders and back
- Short clothes that show the abdominal area.
- Clothes that show the chest and shoulders and are not in line with the nature of the school community and the values of Qatari society.
- T-shirts that contain phrases, slogans, pictures or drawings that violate the values, Qatari identity and Well-established positions of Qatar
- Transparent clothes and light summer clothes that show what is underneath.

General Controls for inappropriate appearance of staff (males and females)

Appearance

The employee does not resemble the opposite sex in appearance and adornment.

Tattoos

Emphasized that tattoos are undesirable and that they should not be visible to students, otherwise they should be covered appropriately.

the hair

Keeping the hairstyles that suit the nature of the school community and the values of Qatari society.

Accessories & Cosmetics

It is not permitted to place jewelry in piercings on the eyebrows, lips or tongue for males and females).

It is not allowed to put jewelry in the ear holes for males.

Note: If there are holes as mentioned above, the jewelry must be removed while on the school premises and during all School activities

Third: School behavior and policies

- Private school and kindergarten Department must update school policies related to the dress code for students and staff Ensuring that it does not conflict with the controls & Instructions stipulated in this circular.
- The kindergarten / school principal constantly educates the school community about the general rules of dress and what is included in the provisions of the ethical charter For private schools).
- The school/kindergarten principal provides constant supervision to monitor any violations of the above controls and take the necessary measures for correction.

Fourth: Final provisions

- The above regulations will enter into force for students' school uniforms starting from the next academic year 2024-2025, with the exception of the regulations related to swimming uniforms and wearing skirts (the requirement to wear women's socks), which will enter into force immediately from the date of this circular.
- The above decree shall enter into force for the staff from the date of this circular.
- It is not necessary to obtain prior approval from the Department of private schools and kindergartens regarding the design of school uniforms for students, provided adherence to the decree stipulated in this circular.
- The kindergarten school principal must sign the pledge to abide by the above regulations (attached), and should be sent within one working week from the date of this circular to the specialist charged with supervising Your school/kindergarten.
- Any violations of the circular's subjects will be monitored by the specialist in-charged to your school/kindergarten during field visits.

Gentlemen/Directors and Directors of Private Schools and Kindergartens,
May God's peace, mercy, and blessings be upon you.

Subject: School uniform

The Department of Private School Affairs in the Special Education Affairs Sector presents you with its warmest regards, wishing you a successful academic year and the following, and in accordance with Law No. (23) of 2015 regarding the organization of private schools, which stipulates that private schools are obligated to respect religious values, customs, traditions, and Qatari heritage..

Therefore, Please be informed of the following:

Uniforms and dress code on school campus

1. Commitment to the appropriate official school uniform that is consistent with the school premises and the values followed in the State of Qatar, as well as in Extracurriculars activities at the school.
2. Taking into account the adherence of the administrative and teaching staff to modest dress in order to represent a role model to be followed, with the importance of constantly educating them the importance of adhering to relevant regulations and laws.
3. When contracting with new employees, all private schools must familiarize them with the regulations and laws regarding the approved uniform that is consistent with the principles of the State of Qatar, provided that the school bears full responsibility in the event that the new employee joining violates the provisions of this law.

Controls for using the school swimming pool:

1. Emphasizing the necessity of modesty while using school swimming pools, adhering to appropriate clothing for swimming, and taking into account the values, customs and traditions stipulated in the law, which are consistent with the principles of the State of Qatar.
2. Schools that implement swimming lessons in their weekly schedule must adhere to separation between the sexes, taking into account the provision of changing rooms commensurate with the number of students in order to respect their privacy inside the rooms.
3. All private schools must separate the genders of boys and girls starting from the fourth grade of primary school, and it is strictly prohibited to mix the genders in the swimming pool starting from the above-mentioned grade, provided that a swimming pool must school is provided that matches the student's gender.

Accordingly, we ask all private schools that wish to provide swimming classes to kindly submit an Approval application for appropriate uniform by the School Affairs Department.
